Auburn Bylaws define a solicitor or canvasser as any person who, for himself or for another person, firm or corporation, travels by foot, automobile or any other type of conveyance from place to place, from house to house, taking or attempting to lease or take orders for the sale of goods, wares, merchandise or services, or taking or attempting to take contributions for any purpose soliciting orders for magazines, books, periodicals or other articles of a commercial nature, the contracting of all home improvements, or for services to be performed in the future whether or not such individual has, carries or exposes for sale a sample of the subject of such sale, whether or not he is collecting advance payment on such retail sales.
