

## STREETLIGHT POLICY

1. Security of Private Property  
The Town of Auburn shall not install streetlights for the purpose of illuminating private property (commercial, industrial and residential) for security purposes. That is the responsibility of the property owner.
2. Entrances to Private Drives  
The Town of Auburn shall not install streetlights for the purpose of illuminating the entry ways to private property. This shall include residential driveways, business entrances, and entrances to private ways. Streetlights shall not be installed along private ways.
3. Streetlights may be erected with the approval of the Board of Selectmen at the following locations:
  - a. Public street intersections
  - b. Bad curves or other serious road hazards
  - c. Areas of heavy evening pedestrian traffic
4. The Board of Selectmen may approve a streetlight when the following conditions have been met:
  - a. A complete application is submitted.
  - b. The request is for illumination of an accepted public way.
  - c. There is a demonstrated need for correcting the hazard with street lighting using the following criteria:
    1. High traffic volumes
    2. Frequent accidents
    3. High evening pedestrian volumes
    4. Recommendation of the Police Chief and Director of Public Works.
  - d. The Police Chief and Director of Public Works certify that other alternatives (better signing, eliminating the hazard, etc.) would not be as effective as street lighting.
