Definitions

False Alarm	Any call for police or fire services that is determined not to have required such services.
Good Intent Alarm	Any false alarm that is initiated by an alarm system or person that reasonably believes there is a need for services.
Accidental Alarm	Any false alarm caused by an external element such as frozen or broken sprinkler heads or pipes or excessive heat.
System Malfunction	Any false alarm caused by mechanical element such as battery failure, faulty detectors or design errors.
Responsible Person	The owner or lessee of the structure in which an alarm system is installed or the person who initiates a malicious false alarm shall be deemed to the person responsible under the terms of this By-Law.
Malicious Alarm	Whoever makes or causes to be made a malicious false alarm shall be punished by a fine of Five Hundred Dollars.

Fire Alarm Fees and Security / Burglar Alarm Fees

1 st	2 nd	3 rd	4 th	5 th & Subsequent
Warning	Warning	\$50	\$75	\$100

The owner and/or lessee of a structure in which an alarm system is installed and which alarm system causes an accidental false alarm or system malfunction false alarm shall be subjected to fine as outlined above. Any alarm caused by while the alarm is being repaired or tested shall be subject to fine as second offense alarm or subsequent alarm. There shall be no punishment or fine for any good intent false alarm or false alarm caused by lightning. Offenses shall be determined and numbered from January 1 of any year.
